I understand and agree that acceptance for membership is subject to approval of Lake Dow Club, LLC ("Club Operator"), or its authorized agent, and the availability of a membership I have applied for, and conditioned upon payment of the required initiation fee in full to Club Operator. Payment of the initiation fee and execution of this application document, any membership agreement, or any other document does not obligate or bind Club Operator to accept my application for membership in the Lake Dow Club; however, in the event that my Application is not accepted, I understand that I will receive a full refund of the amount paid.

I understand that by applying for membership in the Lake Dow Club, I am applying for a non-exclusive license to use all of the facilities of the Lake Dow Club in accordance with the dues category indicated above. If my application is approved and I am accepted for membership, I agree that such membership shall be subject to the terms and conditions of:

- (a) this Application for Membership, including the provisions of this Acknowledgment;
- (b) my Membership Agreement;
- (c) the Policies and Rules as Club Operator and its successors and assigns may establish from time to time.

I acknowledge receipt of copies of the foregoing documents (the "Membership Documents"). I have had the opportunity to review the Membership Documents and to seek professional advice to assist me in evaluating the merits and risks of acquiring a membership in the Lake Dow Club. I have made my decision to acquire a membership without reliance upon any information or representations other than as set forth in the Membership Documents. If accepted for membership, I agree to be bound by and comply with all of the terms and provisions of the Membership Documents, as they may be amended, and to be responsible for compliance by my family members and guests.

I acknowledge that the facilities are currently operated, and managed by Club Operator and that the land upon which the Facilities are located is owned by Lake Dow Property Owners' Association, Inc., a Georgia corporation, and is leased to Lake Dow North Corporation, a Georgia corporation pursuant to a long-term ground lease. In addition, I acknowledge that the facilities are owned by Lake Dow North Corporation and the land and the facilities are leased to Club Operator. Furthermore, I acknowledge that in acquiring a membership, I acquire no rights in or to the land or the facilities of the Lake Dow Club nor any right to participate in the management or control of the land or the facilities of the Lake Dow Club.

I acknowledge that Club Operator shall have the right, in its sole discretion, to discontinue operation of any or all of the facilities of the Lake Dow Club and to sell or otherwise dispose of the facilities in any manner whatsoever and to any person or entity whomsoever, subject to the terms of the Membership Documents. In addition, Club Operator reserves the right and intends to permit use of the Club facilities by persons other than members, including members of the general public, at such times and on such terms and conditions as Club Operator may determine in its sole discretion.

I further acknowledge that I am applying for membership for the sole purpose of obtaining social benefits and recreational use of the facilities and not as an investment or with any expectation of making a profit from the ownership or future transfer of the membership.
